

In 2015, ACU Foundation was proud to make history by being the first organization to rate every single state legislature across the full spectrum of issues, helping each voter understand how his or her state ranks among the rest.

Ultimately, we are trying to help people understand what conservatism *is* and how it improves the lives of everyday Americans. Conservatism is the political philosophy that sovereignty resides in the person. We think that understanding this idea is essential if Americans are to successfully govern themselves again.

Working with our policy centers and fellows, the ACU Foundation engages in deep policy analysis to help create our annual state scorecards. We have enhanced the vote descriptions this year to show this effort more clearly.

By examining all 50 of our State Ratings, we can see which states have most effectively promoted conservative solutions and which have struggled. Our ratings also help identify legislators who have courageously fought against liberal majorities. We hope that this guide helps you learn how well, or poorly, your legislators work to preserve the values we share.

ACU researched and selected a range of bills before the Oregon State Legislature that determine a member's adherence to conservative principles. We selected bills that focus on Ronald Reagan's philosophy of the "three-legged stool": 1) *fiscal and economic*: taxes, budgets, regulation, spending, healthcare, and property; 2) *social and cultural*: 2nd amendment, religion, life, welfare, and education; and 3) *government integrity*: voting, individual liberty, privacy, and transparency. This wide range of issues are designed to give citizens an accurate assessment that conveys which of Oregon's elected leaders best defend the principles of a free society: Life, Liberty and Property.

OREGON SENATE VOTE DESCRIPTIONS

1. **SB 1589 Expanding Corporate Subsidy Program.** This bill expands a government business loan and credit guarantee program designed to help narrowly defined businesses. The funding will go to any business that will “produce substantial benefits for the state.” ACU opposes government programs that favor one business over another and often are the basis for later expansion of the government preferred businesses and opposed this bill. The Senate passed the bill on February 8, 2016 by a vote of 21-8.

2. **SB 1532 Minimum Wage.** This bill creates a complex system of minimum wage laws across the state, with levels rising to \$13.50 in Portland and to lower levels in other parts of the state. ACU opposes these artificial wages that hurt those who need the most help in finding employment, such as students and inexperienced workers and opposed this bill. The Senate passed the bill on February 11, 2016 by a vote of 16-12.

3. **SB 1533 Affordable Housing Set-Asides.** This bill violates private property rights and forces landlords to set-aside 20% of their properties for “affordable housing,” which are prices at below the market rates. The bill also imposes a new 1% excise tax on the permit value of construction projects. ACU opposes arbitrary mandates that drive up the cost of housing for others and opposed this bill. The Senate passed the bill on February 26, 2016 by a vote of 20-8.

4. **SB 1503 Health Insurance Price Controls.** This bill mandates that insurance companies reimburse nurse practitioners and physician assistants at the same rates as physicians. It also prohibits negotiating separate rates for those who are not physicians. ACU opposes this interference in the free market, which will drive up the cost of health insurance for consumers, and opposed this bill. The Senate passed the bill on February 29, 2016 by a vote of 20-6.

5. **SB 1547 Renewable Energy Mandate.** This bill makes Oregon the first state in the nation to ban coal-fired power plants, with a deadline of 2030. The bill also requires the state to get at least 50% of its energy from renewable sources by 2040. ACU believes that all forms of energy should compete within the free market and government should not put its thumb on the scale to favor certain business and opposed this bill. The Senate passed the bill on March 2, 2016 by a vote of 17-12.

6. **SB 1587 Criminalizing the Free Market.** This bill creates a new felony, violating Oregon’s “prevailing wage” laws, and sets the punishment to up to five years in prison. To enforce this, the bill creates three new government positions and sets up new regulations that employers must follow. ACU opposes these artificial wages that drive up the cost of construction projects and opposed this bill that, in effect, makes it a crime to pay wages based on a free market, and opposed this bill. The Senate passed the bill on March 2, 2016 by a vote of 21-7.

7. **HB 4017 Medicaid Expansion.** This bill directs state agencies to develop a plan to expand Oregon’s Medicaid program to include certain immigrants covered by an international agreement known as the Compact of Free Association (COFA). Research based on the ACU Foundation’s Family Prosperity Index shows that increasing per capita Medicaid spending actually has a negative impact on the economy and family prosperity. ACU opposes the expansion of a program rife with fraud and waste, with no reforms, and opposed this bill. The Senate passed the bill on March 2, 2016 by a vote of 18-10.


8. **HB 4037 Solar Energy Subsidies.** This bill gives those who install utility-scale solar installations a direct subsidy. For example a 2 Megawatt installation would receive a direct subsidy of \$57,000 over five years. ACU believes that all forms of energy should compete within the free market and government should not put its thumb on the scale to favor certain business and opposed this bill. The Senate passed the bill on March 2, 2016 by a vote of 22-6.

9. **HB 4086 Unemployment Benefits.** This bill creates a new category of employee: employees who are “locked out” of their place of employment because of a labor dispute. Those employees will receive up to 52 weeks of benefits while others will receive only 26 weeks of benefits. ACU opposes this discriminatory bill designed to benefit employees of one company in Oregon involved in a labor dispute and opposed this bill. The Senate passed the bill on March 2, 2016 by a vote of 20-6.

10. **HB 4143 Rent Control.** This bill creates a series new mandates on landlords, including giving a 90 days’ notice for terminating residency of month-to-month tenants. The bill also allows tenants to occupy the landlord’s private property rent free if the notification policies are not followed. ACU Foundation’s Center for 21st Century Property Rights engages heavily on this issue and opposes housing mandates that drive up prices to consumers and deny the property rights of property owners. ACU opposed this bill. The Senate passed the bill on March 2, 2016 by a vote of 16-9.

OREGON HOUSE VOTE DESCRIPTIONS

1. **HB 4122 Food Labeling Mandate.** This bill mandates that labels be applied to any genetically engineered salmon sold in Oregon. ACU opposes mandates that drive up the cost of food to consumers and opposed this bill. The House passed the bill on February 17, 2016 by a vote of 32-27.

2. **SB 1532 Minimum Wage.** This bill creates a complex system of minimum wage laws across the state, with levels rising to \$13.50 in Portland and to lower levels in other parts of the state. ACU opposes artificial wages that hurt those who need the most help in finding employment, such as students and inexperienced workers, and opposed this bill. The House passed the bill on February 18, 2016 by a vote of 32-26.

3. **HB 4147 Firearm Transfers.** This bill prohibits the transfer of a firearm if the Oregon State Police say they are unable to determine whether the recipient is qualified to possess a firearm. The law before this bill allowed dealers to release a firearm after three days if no decision was reached. ACU supports the founders' belief in the Second Amendment and opposed this bill. The House passed the bill on February 22, 2016 by a vote of 31-28.

4. **HB 4143 Rent Control.** This bill creates a series of new mandates on landlords, including giving a 90 days' notice of terminating residency for month-to-month tenants. The bill also allows tenants to occupy the landlord's private property rent free if the notification policies are not followed. ACU Foundation's Center for 21st Century Property Rights engages heavily on this issue and opposes housing mandates that drive up prices to consumers and deny the property rights of property owners. ACU opposed this bill. The House passed the bill on February 23, 2016 by a vote of 48-11.

5. **SB 1589 Expanding Corporate Subsidy Program.** This bill expands a government business loan and credit guarantee program designed to help narrowly defined businesses. The funding will go to any business that will "produce substantial benefits for the state." ACU opposes government programs that favor one business over another and often are the basis for later expansion of the government preferred businesses and opposed this bill. The House passed the bill on February 25, 2016 by a vote of 37-21.

6. **SB 1503 Health Insurance Price Controls.** This bill mandates that insurance companies reimburse nurse practitioners and physician assistants at the same rates as physicians. It also prohibits negotiating separate rates for those who are not physicians. ACU opposes this interference in the free market, which will drive up the cost of health insurance for consumers, and opposed this bill. The House passed the bill on February 25, 2016 by a vote of 44-15.

7. **HB 4037 Solar Energy Subsidies.** This bill gives those who install utility-scale solar installations a direct subsidy. For example a 2 megawatt installation would receive a direct subsidy of \$57,000 over five years. ACU believes that all forms of energy should compete within the free market and government should not put its thumb on the scale to favor certain businesses and opposed this bill. The House passed the bill on February 26, 2016 by a vote of 51-4.

8. **HB 4086 Unemployment Benefits.** This bill creates a new category of employee: employees who are "locked out" of their place of employment because of a labor dispute. Those employees will receive up to 52 weeks of benefits while others will receive only 26 weeks of benefits. ACU opposes this discriminatory bill designed to benefit employees of one company in Oregon involved in a labor dispute and opposed this bill. The House passed the bill on February 29, 2016 by a vote of 48-10.

9. **SB 1547 Renewable Energy Mandate.** This bill makes Oregon the first state in the nation to ban coal-fired power plants, with a deadline of 2030. The bill also requires the state to get at least 50% of its energy from renewable sources by 2040. ACU believes that all forms of energy should compete within the free market and government should not put its thumb on the scale to favor certain businesses and opposed this bill. 

The House passed the bill on March 3, 2016 by a vote of 39-21.

12. **SB 1587 Criminalizing the Free Market.** This bill creates a new felony, violating Oregon's "prevailing wage" laws, and sets the punishment to up to five years in prison. To enforce this, the bill creates three new government positions and sets up new regulations that employers must follow. ACU opposes artificial wages that drive up the cost of construction projects and opposed this bill that, in effect, makes it a crime to pay wages based on a free market, and opposed this bill. The House passed the bill on March 3, 2016 by a vote of 59-1.
